Getting your documents certified:

You must have someone certify the copies of required identification documents that you send to us. Please refer to the below table for more information on getting your documents certified.

Who can certify copies of documents

You must certify the copies you send to us by one of the following certifiers:

- a Justice of the Peace
- a Notary Public (for the purposes of the Statutory Declaration Regulations 2018)
- an agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
- a permanent employee of the Australian Postal Corporation with two or more years of continuous service who is employed in an office supplying postal services to the public
- an officer with, or authorised representative of, a holder of an Australian financial services licence, having two or more continuous years of service with one or more licensees
- an officer with two or more continuous years of service with one or more financial institutions (for the purposes of the Statutory Declaration Regulations 2018)
- a finance company officer with two or more continuous years of service with one or more finance companies (for the purposes of the Statutory Declaration Regulations 2018)
- a member of the Institute of Chartered Accountants in Australia, CPA Australia or the National Institute of Accountants with two or more years of continuous membership
- a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner (however described)
- a judge of a court
- a magistrate
- a chief executive officer of a Commonwealth court
- a registrar or deputy registrar of a court
- a police officer
- an Australian consular officer or an Australian diplomatic officer (within the meaning of the Consular Fees Act 1985).

Not in English?

In Australia, translations should be done by translators accredited by the National Accreditation Authority of Translators and Interpreters ('NAATI"). You can find an accredited translator by looking up or contacting NAATI.
