HOW TO COMPLETE THIS FORM

- Step 1** **Please ensure you have completed the following:**
- written your account number and investor name as it appears on your latest statement
 - written the amount in either Australian dollars or units if you are making a partial redemption, or mark 'Full Redemption' if you wish to make a complete redemption
 - confirmed your bank account details
 - signed the form as per the 'Acknowledgements and signatures' in **section 4**.

If your balance after redemption is lower than the minimum we will contact you as we may be unable to process your request.

Signing instructions

If the company (pursuant to section 204A of the Corporations Act 2001) does not have a company secretary, a sole director can also sign alone. Otherwise this form must be signed by a director jointly with either another director or a company secretary. Please indicate the capacity in which the form is signed.
- Trust** - the trustee(s) must sign this form. Trustee(s) signing on behalf of the trust confirm that the trustee(s) is/are acting in accordance with such designated powers and authority under the trust deed.
- Power of Attorney** - if you have not already lodged the Power of Attorney with us, please attach a certified copy of the Power of Attorney document that includes Certificate of Witness and Statement of Acceptance and Certified Identification Document of the Power of Attorney.
